All accepted entries received with payment by December 31st, 2017 will receive a show plaque, event t-shirt (S-XL) and 2 Exhibitor passes, all distributed during load in day. Entries received after December 31st, 2017 will receive 2 Exhibitor passes. Owners may be accompanied by two helpers to help clean and set up car on load in day. Weekend passes will be available for purchase during load in day only and will be paid for at that time. Additional event t-shirts will be available for purchase at the event during public hours. Stanchions and other items can be rented from QCCA at their discretion for additional costs and must be requested in advance and paid to QCCA according to their wishes .
